Message from the President

In the picture below I am holding an invitation to the Pioneers of Piscataqua meeting in 1982. At that time the meetings were held at "Yoken's Thar She Blows" in Portsmouth. I really wanted to attend that meeting but was living in Oklahoma at the time.

Although I was born and raised in Lynn, MA, my father was born and raised in North Conway, NH. I spent many summers there. Dad was one of

nine children. There were always a lot of cousins to play with and aunts, uncles, grandparents, and even great grandparents to be with. If you had asked any of the adults if they knew of their origins, they would have nodded, "I don't know".

My grandmother's name was Rachel Seavey. There is a Seavey Street off Main



Street in North Conway. Her family, as well as my paternal grandfather's family, was among the first settlers. I was always curious about my father's family roots.

The year was 1976. Our nation was celebrating its' Bicentennial. I was a graduate student pursuing an M.A. in History and taking a course entitled "The History of Massachusetts". I thought that perhaps my family's story might lead me to a topic for my thesis. I had little to go on.

I was told that both my grandmother and her mother were members of the Daughters of the American Revolution. However, they never completed their paperwork. So, I started my genealogical journey while living in Oklahoma and without the use of the modern research tools of today. The process was long and arduous.

After many years of research, I did become a DAR. I also am a member of many societies including the Mayflower Society, The Daughters of the War of 1812, the National Society of the Daughters of the Union, New England Women, the Society of the Descendants of the Founding Families of New England, the Society of the Descendants of Charlemagne, and the Pioneers of Piscataqua.

The Pioneers of Piscataqua intrigued me. I wondered why my ancestors were there at the time and found the history fascinating. Although I had many ancestors to choose from to join, I chose Thomas Hanson. My great grandmother was Susan Hanson.

Thomas was a Quaker. He was born in Ipswich, England in 1586 and was given a land grant near Salmon Falls. He was married to Mary Paul. Mary, their son Tobias and his wife were all killed in the famous Waldron raid, also known as the Cocheco raid. The date was June 28, 1689.

I was a history teacher who taught grades 7-12. In 1989 I made a career change and worked for Air Canada until my retirement in 2009. I have been married for 53 years and our daughter has blessed us with four amazing grandchildren ranging in age from 14-24.

As your president I will be at the ready to assist you and answer any questions that you might have. You are in good hands with a very hardworking Council. One of my goals will be to do more research on the Piscataqua history, especially the Indians raids which occurred at that time.

ANNUAL MEETING—JULY 31, 2021 The Elks Lodge, Portsmouth, NH

At 10:10am, President Betsey Cox-Buteau called the Annual Meeting of the Piscataqua Pioneers to order with about 23 members in attendance. Following the invocation and the pledge of allegiance, Betsey welcomed the membership, their guests, and Council members present. Betsey took a moment to recognize Past Presidents Ed Batchelder, Barbara Alex, Barbara Weiden, Virginia Spiller, and Tylene Jousse. She thanked Arlene Thomas for a \$50 donation as well gave a small gift to Treasurer Carla Mueller who was completing her term on the Council. Carla has been a member since 1992. Betsey presented Barbara Weiden, who joined in 1973, was President in 1983, with a corsage. She then polled the members present for their longevity in the organization. Several had been members for 30+ years. Then, Barbara Alex read the mission statement.

REPORTS

Minutes - The minutes from the 2019 Annual Meeting were presented by the Beverly Mutrie, the Secretary. There were no questions, but due to the lack of a quorum of 25 members, the minutes could not be approved and were tabled until later in the meeting when more members were expected.

Treasurer's Report - Carla Mueller presented her report. Virginia Spiller suggested that we also report on difference between last year and this year's balance. She would like members to be made aware of the shortage of funds issue.

Registrar's Report - Wendy Blood reported that we have eight prospective members, mostly from the mid-west. One ready applicant would be nominated later in the meeting. We also have new membership pins for sale.

Chaplain's Written Report - Stated that we had eleven members pass away since our last meeting in August of 2019 including past president Ann Morton.

Database Manager's Report - Ray Gervais reported that we 410 active members, of which 340 were life members and 55 were annual members, with 22 members having a supplemental membership.

Curator's Report - Barbara Alex reported that she had received some antique photograph albums from Charles Wendell with many captioned pictures of his ancestors including the Snells, Leightons, Jennesses, and Demeritts, mostly from Dover, NH which she displayed for pictures.

NEW BUSINESS

Bylaw Changes - We discussed the Council's recommended bylaw changes in depth. One recommendation was to eliminate the requirement for changes of gender in the vice-president line. Mrs. Spiller explained that that provision was instituted in 1905 so that males and females would be equally represented as they have different talents. We discussed the change in term limits. Some felt that one year was too short, as the presidency especially, needed a learning curve. The discussion concluded without a motion as a quorum had not yet been met to enact business.

RECESS

The meeting was recessed for membership to share their stories, for lunch, and the speaker's presentation.

RESUMPTION OF THE BUSINESS MEETING The business meeting was called back to order with a quorum now present.

REPORTS

Janet Clark moved to accept the 2019 Annual Membership meeting minutes. This was seconded by Virginia Spiller. The motion carried.

NEW MEMBERS

Wendy Blood moved to accept Jason Richards as a new member. This was seconded by Barbara Alex. The motion carried.

NEW BUSINESS

Joyce Davies moved to accept the proposed changes to the bylaws. This was seconded by Anne Merrill. The motion carried.

THE NOMINATING COMMITTEE

Ed Batchelder reviewed the nominations for the 2021-2022 Council. Patricia Twombly-Karakashian was nominated for President. Arlene Quimby, Vicki Thomas, Ed Batchelder, and Barbara Carmone were nominated as Vice Presidents. Beverly Mutrie was nominated to remain as Secretary. Wendy Blood was nominated to remain as Registrar. Betsey Cox-Buteau was nominated as Treasurer. Ray Gervais was nominated to remain as Database Manager. Barbara Alex was nominated to remain as Curator.

and Carol Palmer to remain as Auditor. Ed Bachelder made a motion to approve the modified slate. Arlene Quimby seconded the motion. The motion carried. Carla Mueller then made a motion to elect the new slate. This was seconded by Barbara Alex. The motion carried. The officers were then inducted by Tylene Jousse.

Betsey Cox-Buteau was presented with an original Piscataqua Pioneers pin as a token of our esteem and for her extraordinary efforts during her two-year term. The meeting then adjourned at approx. 1:30 pm.

DATABASE MANAGER'S REPORT—OCTOBER 23, 2021

There are 1,884 member records in our database. These records include 408 active members, of which 337 are Life members, 48 are Annual members and 23 members have additional Supplemental memberships. The remaining records consist of deceased, resigned, dual addresses or inactive members. To-date, there are 31 members who have selected to receive their newsletters via email.

CURATOR'S REPORT – OCTOBER 30, 2021

There have been no book or genealogical donations to the Piscataqua Pioneers since the spring. If anyone has any, please use the link on the Piscataqua Pioneer website under "Contact", then look for **Donations to the Curator** and send an email regarding your intentions.

The Piscatagua Pioneer Lamson Collection at the Dimond Library, University of New Hampshire in Durham, NH is now open to visitors from Monday thru Thursday from 11:00 AM - 4:30 PM. However, you must call (603) 862-2714 two days before your intended visit to let them know when you are going to visit. This two-day rule used to apply only to accessing Piscataqua Pioneer material that is stored offsite but now it applies to everything in our collection. Your Piscataqua Pioneer membership card is still required to be shown upon your arrival at the library if you are going to access the membership applications that are stored offsite, but it is not necessary to show this if you are going to research from the vast number of books in our collection. Most researchers have at least one "brick wall" in their research, so this would be the ideal time to pursue this.

NEW BUSINESS

The Treasurer brought forward a **proposed FY22 budget** for discussion. The FY22 budget is available on our website at http://www.piscataquapioneers.org/annual2021/2021-2022-Proposed-Budget.pdf. There was much discussion and some changes made. Wendy Blood

proposed dropping the Registrar's fees in lieu of new and upgraded memberships to several online ancestry databases to be used in her research to verify membership. Her proposal was accepted, and the adjustments were made to the budget. Finally, Betsey Cox-Buteau made a motion to approve the new budget as amended. This was seconded by Ray. The motion passed unanimously in the affirmative.

Susan Winch, our website designer, sent a proposal to the Council to **upgrade our website** to make it more responsive to different formats. The website format dates from 2012. This upgrade to the website would make it tablet and cell phone friendly. The proposal was for \$20 per hour or a total of \$200, whichever was less. Betsey CoxButeau made a motion to accept the proposal. Ray Gervais seconded. The motion passed unanimously in the affirmative.

Betsey Cox-Buteau made a motion to adjust the bottom line of the new budget by \$200 to meet the new expanse. Beverly Mutrie seconded. The motion passed unanimously in the affirmative.

Wendy Blood will **update the membership application** to take out the sponsor and endorser requirement and will also design a "Rack Card" (~4x11), printed both sides usually in color to place around town in touristy/genealogical areas. A "how did you hear about us?" query line will be added to the updated membership application to collect data on how we are found by applicants.

Betsey Cox-Buteau proposed a **change to the by- laws** to be brought to the 2022 annual meeting to reduce the quorum for the annual business meeting to 15 from 25 as a quorum of 25 members is difficult to meet. Pat Twombly-Karakashian seconded the motion. The motion passed unanimously in the affirmative.

Betsey Cox-Buteau made a **motion to adjourn** which was seconded by Vicki Thomas. The motion passed unanimously in the affirmative. The meeting adjourned at 3:10pm.
