COUNCIL MEETING MINUTES

April 30, 2022—Beverly Mutrie, Secretary

In Attendance - Pat Karakashian, President; Beverly Mutrie, Secretary; Wendy Blood, Registrar; Ray Gervais, Database Manager; and Barbara Alex, Curator; Barbara Carmone, Vice-President (arrived 11 am)

Absent: Betsey Cox-Buteau, Treasurer

Pledge of Allegiance, Invocation, Mission, and Objects of the Society – Pat Karakashian

Approval of Minutes: The minutes from the October Council meeting were reviewed and one typo corrected. They were approved as amended.

Chaplain's Report: Fred Boyle was invited by Barbara Alex to write a remembrance about his wife Barbara who recently passed. Wendy opined that that might set a precedent. We instead asked Barbara to have Fred share his memories with our organization for the newsletter which might be of interest new members. The Council expressed a desire to know how Deb Bayles found the names of the seven recently deceased. Barbara Alex will ask Tylene Jousse to just do Necrology. Wendy will ask Tylene about being Chaplain next year.

Treasurer's Report: Pat would like to ask for more donations from the Website. \$468 total so far. The annual New Hampshire Nonprofit Report was filed. It incurred a \$75 Revival Fee because it had lapsed. Betsey sent the check for \$500 to hold the Wentworth Hotel function space. She mentioned PayPal use in about 60% of the time. Betsey has created a spreadsheet of all expenses and income transactions. She will be rebilling for dues from 13 members who have not yet paid for this year. Carol Frost was an associate member, but now her husband is deceased. Barbara Alex will call Carol.

Pat made a motion to file the Treasurer's Report for audit. Beverly Mutrie seconded the motion. The motion passed by a vote of 6-0-0.

Betsey mentioned in her report that a Conflict-of-Interest article needed to be added to the Bylaws as required by the state. Registrar's Report: Wendy reported that Peter Williamson will have #1901, William Fahey, #1902, Ron Berry, #1903 (all male side ancestors), Claire White #1904 and Virginia Argeros, #1905. We have 5 potential members and 17 outstanding prospective members. A new ancestor has been determined, Edward West, who was proved to be a Pioneer. She would like to create a map with pins that identify members' abode to put on view at the Annual Meeting. Wendy will talk about Portsmouth sites with slave associations relating to our original settlers for the Trolley Tour.

The Registrar's report is on the website along with applications for members. Wendy asked if the organization should keep the category of Associate Member. They have paid dues and voted at the Annual Meetings. After discussion, it was decided that it should stay as is. New applications are coming from our website.

Database Manager's Report: Ray handed out a complete list of all active members. There are 1888 members; 387 are active Life members, 22 Supplemental members, and 43 active Annual members paying annual dues. Only 39 members have signed up for electronic Newsletters. It was suggested that members be actively encouraged to choose to receive the Newsletter electronically as it is increasingly expensive to print and mail. Ray reported that Alan Moulton, who wrote the database program, will be taking over the database next year. We thanked Ray for his dedicated service. New members vs deceased members numbers are holding steady.

Curator's Report: Bob LaBelle donated seven volumes of the "Great Migration, Immigrants to New England," published by NEHGS in Boston. They will be housed at Dimond Library. Pat recommends Ray Thompson's book "First Yankee" which goes back to 16th century England. Wendy would like to ask the Portsmouth Discovery Center to sell it for us, but they may ask for a commission. Wendy was asked to discuss it with them.

New Business:

Betsey suggested that we consider eliminating the Chaplain's position and the two Members-at-Large positions from the Council in the Bylaws. We have trouble filling those slots and those who have held them rarely, if ever, come to Council meetings and participate. Pat believed since Betsey proposed this, we should wait for her input. We did, however, agree again (see minutes of Oct. 21) to drop the quorum necessary for holding an Annual Meeting from 25 to 15 members to alleviate last year's situation.

A motion was made by Wendy to bring to the Annual Meeting for a vote to change to a 15-member quorum for the Annual Meeting. It was seconded by Beverly. The motion passed 6-0-0.

We thought that Barbara Carmone would be well suited to fill a Member-at-Large slot and she agreed. We'll leave the Members-at-Large positions alone. Wendy suggests that a visiting minister could just come to the Annual Meeting to give the invocation, benediction and do the induction of officers. We agreed. She will ask her possible chaplain.

2022 Annual Membership Meeting: Pat reviewed the Annual meeting set for July 30th at the Wentworth-by-the-Sea. The menu will be the NE Coastal Buffet. Information will be on the website. The meet and greet will begin at 9:30am, followed by the business meeting. Pat asked Wendy to help with centerpieces. Lunch will be from 12:30-1pm, after which we will have the installation of new officers. With dessert, Pat will give remarks and a short history lesson with the microphone provided. There will be an optional Trolley Tour (seating 32 people) costing \$18 at 1 pm. Wendy will be the guide for the Portsmouth sites. Everyone agreed that we would like to make the meeting "fun". Raffles of memorabilia with tickets, door prizes, sales of items, voting cards needed, etc. The tea or coffee will be courtesy of some kind benefactors. Up to 80 people can fit in the room. Wendy will ask the Wentworth if they have Zoom capability. We need more committees/members to help. Pat will ask in the Newsletter for members to help fill positions. Paul Reardon, the trolley owner, requested a signed contract from us. Wendy will expedite the process.

SOME HISTORICAL INFORMATION

by Patricia Twombly-Karakashian

The following is a Summary of an article by *Patricia Twombly-Karakashian* based on the book "A Historical Sketch" by William D. Knapp, Somersworth, NH: [publisher not identified], 1894 and listed in WorldCat ®, the world's largest network of library content and services. Much of North America was claimed by England because of the discoveries of John Cabot and his three sons, who in 1496 were commissioned by Henry the Seventh "to sail to all parts, countries, and seas of the east of the west, and of the north, under our banners and ensigns, with five ships of what burthen and quantity soever they be, and so many mariners or men as they will have with them in said ships, upon their own proper costs and charges, to seek out, discover and find whatsoever isles, countries, regions, or provinces of the heathen and infidels, whatsoever they be, and in what part of the world soever they be, which before this time have been unknown to all Christians," to take possession in the name of the King of England, and his vassals to conquer, possess, and occupy "enjoying for themselves their heirs and assigns forever, the sole right of trading thither paying the king, the in lieu of all customs and impositions, a fifth of all net profits."

In 1497, they discovered Labrador, and sailing along the coast, claimed all the territory north of the Gulf of Mexico. In 1620, the attention of the English people seems to have been turned especially to this northerly part of the new world, with a view of colonizing it. By November 1620, the English King by his sole authority, constituted a council of forty. This council was established in Plymouth, in the county of Devon for the planting, ruling, and governing of New England in America.

A grant to Edward Hilton in 1629 conveyed "all that part of the river called Pascataquack. The river was known as Pascataqua from the sea to Quampegan Falls, near which was established a plantation called Newwannok on the opposite site of Hilton's grant."

The primary object of settlements near the mouth of the river were to catch fish and to trade with the natives. In 1633, a Captain Wiggin surveyed and laid out the town of Dover. This survey included what we now know as Dover, Somersworth, Rollinsford, Madbury, Lee, Durham, and a part of Newington.

In 1623, Sir Fernando Gorges and Captain John Mason had obtained a land grant lying between the Merrimack and Sagada Hock rivers. Subsequently, Gorges and Mason divided their grant, the former taking a new grant of the part east of the Pascataqua and calling it the State of Maine, and the latter taking a new grant of the part west of the Pascataqua as follows, "All that part of the mainland in New England lying upon the seacoasts, beginning from the middle part of the Merrimack river and from thence to proceed northwards along the seacoast to Pascataqua rivers." Mason named his new grant, "New Hampshire" for the county that he had lived in England.
