### COUNCIL MEETING DRAFT MINUTES

### April 13, 2024—Beverly Mutrie, Secretary

The meeting was called to order by President Ed Bachelder at 1:02 pm with Betsey Cox-Buteau, Treasurer; Beverly Mutrie, Secretary; Wendy Blood, Registrar; Michael Denney, Curator; Alan Moulton, Database Manager; and Pat Karakashian, Officer at Large present. M. Denney and E. Bachelder attended online.

The minutes of the fall Council meeting were approved upon a motion by B. Cox-Buteau, seconded by W. Blood and all concurred.

The Treasurer summarized her report as of April 1, 2024. Total year-to-date income was \$5157 against expenses of \$4527. Our current assets including cash and memorabilia are \$39,284. B. Cox-Buteau motioned to forgo the Fall Newsletter and just have a Spring one. B. Mutrie seconded and all voted in the affirmative. A motion was made by B. Cox-Buteau to send a paper copy of the Spring Newsletter to all active members unless they preferred getting it by email. P. Karakashian seconded the motion and all agreed. There will still be minutes and a recap of the Annual Meeting online in the fall.

The Registrar gave her report as of April 13, there are 6 new members. Two completed applications have been received as well as 4 preliminary applications. There are 16 applications still awaiting paperwork. Four preliminary applications' nominees from Linda Bean, recently deceased, will be contacted by W. Blood.

A motion from W. Blood to approve #1901.1, Peter Williamson, #1915.3 and #1915.4 for Michael Denney, #1932.1, #1931.2 for Wayne Clark and #1935, Rebecca Bachelder for membership was made. B. Cox-Buteau seconded the motion, and all agreed.

**The Database Manager,** A. Moulton, reported that we have had five deaths since the Annual Meeting, with 371 active members, a total of 1900 records with 10 address changes, and 10 new members.

**M. Denney, Curator,** reported that he has had trouble accessing our records at the Dimond Library. The Council will try to resolve the issue soon. He also would like to donate 8 volumes of the Jordan genealogy to our collection or perhaps to the Portsmouth Library.

**Nominating Committee:** Pat Karakashian and E. Bachelder reported that our 1<sup>st</sup> V.P., our Chaplain, and an Officer at Large are up for nomination at the Annual Meeting. Prospective nominees include Rebecca Miller and other meeting participants along with the current officers.

B. Cox-Buteau made a motion to eliminate Section 3 of our By-Laws and replace it with "The Council may hold meetings by electronic means as desired". W. Blood seconded the motion and all concurred.

**Annual Meeting:** The speaker, Dennis Robinson, has been hired. Sales of the memorabilia, baskets, and raffle tickets with the silent auction winning bids contributed greatly to the financial success of the meeting. A motion by B. Cox-Buteau and seconded by A. Moulton to charge \$65pp for the Annual Meeting was made and it passed.

A motion to adjourn was heard at 2:40 pm, seconded by A. Moulton and all agreed.

#### PROPOSED PIONEERS BYLAWS AMENDMENT

### **ARTICLE V. Meetings**

Section 3: If a Council Member is unable to be physically present at a meeting of the Council, the Member may request to attend the meeting by way of electronic means. The Member must submit a written or electronic request to the President at least one week prior to the scheduled meeting, offering a reasonable explanation for the request. The President will determine if the explanation is acceptable for remote attendance. The explanation for the remote attendance must be included in the minutes of the meeting. Attending the meeting by such means will allow the electronic attendee full participation, including all discussion and voting, and such participation will allow the electronic attendee to be counted in the number of participants needed to meet the quorum requirement of a council meeting. Each part of the meeting must be audible to all of the participants at the physical location of the meeting. All votes taken during such a meeting must be cast and recorded by roll call vote. The Council may hold meetings by electronic means as desired.
