

### DRAFT MINUTES OF THE PISCATAQUA PIONEERS SPRING COUNCIL MEETING HELD ON APRIL 5, 2025: B. Mutrie, Secretary

Present in person at 1:05 p.m. were Wendy Blood, Registrar; Betsey Cox-Buteau, Treasurer; and Beverly Mutrie, Secretary. Attending by electronic means were Ed Bachelder, President; Rev. Michael Denny, Curator; Barbara Carmone and Patricia Karakashian, both Officers at Large; and Wendy Renda, Vice President. A quorum was present.

Rev. Michael Denny gave the invocation. P. Karakashian reported that she had secured a speaker for the Annual Meeting on July 26: our member, Virginia Argeros, who will speak on the Scots Irish immigrants.

E. Bachelder moved to hold the Annual Meeting at St. James Hall in Hampton. B. Mutrie seconded the motion, and all concurred. E. Bachelder then moved that the luncheon be self-catered. W. Blood seconded, and all agreed. B. Cox-Buteau moved to charge each attendee \$40 for lunch. W. Blood seconded the motion, and all voted affirmatively.

**Spring Newsletter:** Reports from the Secretary, Curator, Treasurer, Database Manager, and Registrar will be included, along with the form for Annual Meeting reservations.

W. Blood moved to approve the proposed five new members (Rose Linfoot #1941, Frederick Trail #1942, Kristen Jensen #1943, Asher Jansen #1944, and Auden Jansen #1945) and seventeen supplementary ancestor applications (13 from S. Beverage #1891, 3 from M. Denney #1915, and 1 from F. Trail #1942). B. Cox-Buteau seconded the motion, and all approved. At least two of the new members will be life memberships.

E. Bachelder proposed the following slate of officers for election at the Annual Meeting: Wendy Renda as President, Ed Bachelder as Database Manager, Beverly Mutrie as Secretary, and Mike Denney as Curator. B. Mutrie moved to accept the proposed slate. W. Blood seconded the motion, and all approved.

#### **Treasurer's Report:**

The Treasurer reported that the budget for the Annual Meeting will be \$1,700. She has filed the Annual and Five-Year State of NH reports. The proposed budget for total annual expenses is \$4,750, which includes funds for a postcard mailer for the Annual Meeting and the newsletter. She has also budgeted \$200 for archival storage at UNH. B. Cox-Buteau moved to approve the \$4,750 budget, with W. Blood seconding the motion. All concurred.

#### Miscellaneous:

B. Cox-Buteau will instruct Susan Winch not to keep original webmail communications once they have been forwarded to an officer as per the discussion by the Council. A Vice President will be needed as Facebook manager. After the Annual Meeting, the remaining 2015 Registrar books will be donated to libraries or societies or recycled. Information on new ancestors and their descendants (names only) will be published online once transferred from the Registrar's files.

B. Cox-Buteau moved to appoint herself, W. Blood, M. Denny, and B. Mutrie as a committee to inventory the Hauk Storage Unit and determine how to eliminate or store its contents elsewhere. E. Bachelder seconded the motion. B. Mutrie amended it to enable the unit's closure. All approved.

The Council requested that W. Blood explore reducing the cost of the P.O. Box, as it is underutilized. B. Cox-Buteau moved to eliminate the Officer-at-Large positions. Any who wish to remain on the Council will move to the Vice Presidents. W. Blood seconded the motion. After discussion, a vote was taken, with five in favor and two against. A proposed bylaw change to that effect will be drafted by B. Cox-Buteau and printed in the Spring Newsletter.

E. Bachelder will contact the Quimby / Chadbourne contingent and invite them to attend the Annual Meeting and/or become members of the organization. M. Denny will be attending the Hereditary Fortnight activities in Washington, D.C. and hopes the Piscataqua Pioneers might join

in the future, as it offers good exposure for the organization.

The next Council meeting will be held on October 18 at 1:00 p.m. A motion to adjourn was made by B. Mutrie, seconded by B. Cox-Buteau, and approved at 2:50 p.m.

By email, the Council approved eliminating the revised Officer Terms amendment to the bylaws from two years ago, as it is no longer pertinent.

# DRAFT 2024 ANNUAL MEETING MINUTES FOR APPROVAL AT THE 2025 ANNUAL

**MEETING:** B. Mutrie, Secretary

We met in the ballroom at Wentworth by the Sea for the 120th Annual Meeting of our Society. Ed Bachelder, President, called the meeting to order at approximately 10:20 a.m. There were 46 paid attendees, of whom 25 were members. Nancy Spencer-Smith, Chaplain, gave the invocation. Wendy Renda, First Vice President, led the Pledge of Allegiance, and Arlene Quimby, Officer at Large, read the Mission Statement and the Objects of the Society.

The minutes of the 2024 Annual Meeting, as written by B. Mutrie, Secretary, were approved upon a motion by N. Spencer-Smith, seconded by B. Cox-Buteau, with all voting affirmatively.

B. Cox-Buteau, Treasurer, reviewed her report. She noted that the CD earning 5% interest was rolled over again at Service Credit Union. Carol Palmer, Auditor, reviewed and confirmed the report's accuracy. Our net income for the year was approximately \$352. The largest expense continues to be the Annual Meeting. Only a spring newsletter will be printed and mailed; the fall newsletter will be sent electronically.

Registrar Wendy Blood reported a strong interest in membership, especially in associate memberships. There are 16 new members to be voted in today, in addition to the 18 approved by the Council this spring, for a total of 34. There are 19 applications still in progress. N. Spencer-Smith moved to approve the following new members: #1936 Kristy Lee, #1937 Sandra Beverage Andrews, #1938 Eugene Walker, #1939 Jason Huckabee, #1940

Catherine Stearns,#1941 Rose Linfoot, along with 5 supplemental memberships for Stephen Beverage (#1891) and 4 supplemental memberships for Michael Denney (#1915). B. Mutrie seconded the motion, and all voted affirmatively.

N. Spencer-Smith gave an oral report of the names of 12 members who have passed away since the last Annual Meeting.

Alan Moulton, Database Manager (not present), submitted a written report stating that we currently have 363 active members, with a total of 1,914 records on file. He is working on creating an instruction manual, clearing redundant data fields, and eventually compiling a glossary to define each data field.

B. Cox-Buteau reported that the Council proposes a bylaw change regarding Council members attending meetings remotely. The proposed Article V: Meetings By-Law was shortened to state: "The Council may hold meetings by electronic means as desired." E. Bachelder moved to accept the amendment, with a second by Steve Beveridge. A hand vote was taken, with 25 members voting affirmatively and no dissenting votes. The motion met the two-thirds majority requirement and passed.

A motion to approve the incoming officers for their new term was made by E. Bachelder and seconded by B. Cox-Buteau. The membership voted affirmatively to elect the officers to a two-year term. The incoming officers are: Ed Bachelder, President, Wendy Renda, Vice President, Nancy Spencer-Smith, Chaplain, then Patricia Karakashian, Arlene Quimby, and Barbara Carmone, Officers-at-Large.

The business meeting adjourned at 10:58 a.m. upon a motion by B. Cox-Buteau, seconded by S. Beveridge, with all concurring.

#### NOTICE OF MOTION TO AMEND THE BYLAWS:

The Council moves to eliminate all "Officer-at-Large" positions on the Council and move present Officers-at-Large to fill the vacant Vice President positions should they wish to continue on the Council. Also, to add language recognizing the alternation terms and also to remove the now obsolete language that was inserted to make the transitions to alternating terms which are now established.

#### "ARTICLE IV: Officers" would read as follows:

Section 1. Officers of the Society shall consist of a President, three (minimum) to five Vice Presidents, Chaplain, Secretary, Treasurer, Registrar, Curator, Auditor, Database Manager, and three to five Officers-at-Large-all of whom shall be elected at the an Annual Meeting. All positions on the Council will serve two-year terms except for the Registrar, Treasurer, and Database Manager who will serve three-year terms.

In order to provide for the stability of the Council, the change to the length of the terms for these offices will be staggered over the next two elections. To facilitate this change, the following FY24 positions will be voted in as one year terms: 2 Vice Presidents, Chaplain, Curator, and 3 Officers at Large. The remaining offices which include the President, 3 Vice Presidents, Secretary, Auditor, and 2 Officers at Large will be voted in for two-year terms across FY24 and FY25. After that, all terms will be elected for two-year terms as the positions come up for election.

# ANNUAL MEETING PROGRAM: Battle of Dunbar And Scottish Prisoners of War in the American Colonies of Massachusetts, New Hampshire, And Maine.

In September 1650, the quiet town of Dunbar, Scotland, became the site of a dramatic and pivotal clash between two former allies—England and Scotland. This fierce battle ended in a decisive victory for Oliver



Cromwell's English forces, marking a turning point not only militarily but also politically, as it crushed Scottish hopes of restoring Charles II to the throne. In the aftermath, thousands of Scottish soldiers were captured, and among them, 150 were transported across the Atlantic to Charlestown, Massachusetts. There, they were sold as indentured servants, forced to rebuild their lives in a strange new world. Torn from their homeland, these men would never return to Scotland nor see their families again. This presentation explores the remarkable journeys of several of these Scottish prisoners and the lives they forged in the early American colonies of Massachusetts, New Hampshire, and Maine.

Ginny Argeros is a longtime member of the Piscataqua Pioneers and also belongs to many other heritage groups. She became interested in the Scottish POW story after her family research led her to two known Scottish POWs in Maine. She is happy to share her research with us at the 2025 Annual Meeting.
